Sandra,

Attached please find PDF copies of e-mails we exchanged earlier this year, which should provide you with a "[record of telling you there was no money left.](#)" As you'll see, you wrote that of the \$22 million originally appropriated for SERVE, \$22 million dollars had been spent and then you repeated this point by saying, "There is no saved money."

It was your answers to my questions about SERVE funding that led me to wonder how SERVE would have been funded between February and November of this year if all the money appropriated for it had been spent and there was none left.

If I misunderstood what you said, could you clarify whether or not SERVE had depleted all of its appropriated funds by the end of January, 2004, when it was shelved by Deputy Defense Secretary Wolfowitz?

If it had depleted its funds by January, 2004, was FVAP planning to ask Congress for more money to complete, deploy, and use SERVE in the November, 2004, elections, had Deputy Defense Secretary Wolfowitz not decided not to use the system then?

If it had depleted its funds by January, 2004, and FVAP wasn't going to ask for a supplemental appropriation, how was FVAP planning to fund SERVE between January and November, 2004?

Several months ago, you told me that there was no money left out of the \$22 million appropriation for SERVE when the program was shelved in January, 2004. According to the documents I've just received under an FOIA request, SERVE was scheduled to go out of business on March 31, 2005. I'd like to know how SERVE intended to be funded during the final 15 months of its existence.

Also, I'd like to know what DOD knows about, and/or is lobbying for, in terms of the renewal or extension of SERVE in the latest Defense Appropriations Bills now pending in Congress.
